**ARTICLES OF AMENDMENT TO THE CHARTER**

**OF**

**Tennessee Artist-Craftsmen's Association**

Pursuant to the provisions of Section 48-60-105 of the Tennessee Nonprofit Corporation Act, the undersigned corporation adopts the following articles of amendment to its charter:

1. The name of the corporation is Tennessee Association of Craft Artists

2. The text of each amendment adopted is:

The Tennessee Artist-Craftsmen's Association is to be known henceforth as the Tennessee Association of Craft Artists.

3. The corporation is a nonprofit corporation.

4. The manner (if not set forth in the amendment) for implementation of any exchange, reclassification, or cancellation of memberships is as follows:
